### **1. PRODUCT DESCRIPTION:**

#### **Glasron Wool GC16, GC20, GC24 and GC32**

Glass wool glued by SBR resin adhesive, weight: 45g/m<sup>2</sup>, to a glass cloth (210 ± 21g/m<sup>2</sup>).

The glass wool contains 92.4~98.0% (± 1.0%) Glass and 2.0~7.6% (± 1.0%) Phenol resin (Weight ratio).

Maximum organic content: 7.80% at the tested density 37.94 kg/m<sup>3</sup>

5.32% at the tested density 19.27 kg/m<sup>3</sup>

Nominal density: GC16: 16 kg/m<sup>3</sup>, GC20: 20 kg/m<sup>3</sup>, GC24: 24 kg/m<sup>3</sup> and GC32: 32 kg/m<sup>3</sup>

### **2. DOCUMENTS AND DRAWINGS:**

4.2 - The products may be used as an integrated part of approved fire resisting divisions only when tested as such.

5.1 - This certificate alone does not allow the applicant to issue the Declaration of Conformity and to affix the mark of conformity (wheelmark) to the products corresponding to this type. To this end, the production-control phase module D Production Quality Assurance or module E Product Quality Assurance or module F Product Verification of Annex II of the Directive is to be complied with and controlled by a written inspection agreement with a Notified Body.

### **6. MARKING OF PRODUCT:**

6.1 - Reference is made to MED 2014/90/EU chapter 2.
